SOCIETY FOR THE WELFARE OF THE MENTALLY RETARDED was established in 1968 and it was the first group of parents that enrolled their children with us.

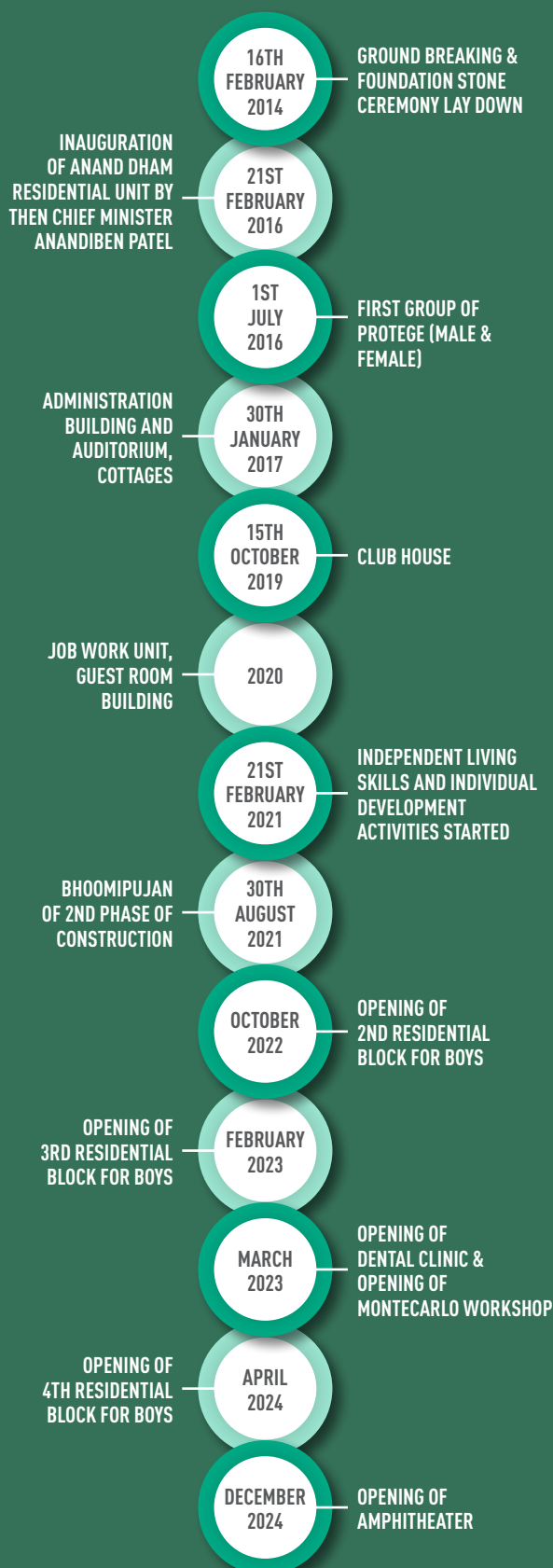
The aim of the association was to comfort the parents and answer their question **'Who will take care of our children after us?'**.

To fulfil parents' concerns AASTHA CHARITABLE TRUST FOR THE MENTALLY CHALLENGED was formed with the mission to provide a dignified life and qualitative care through a residential 'HOME' for the persons with intellectual and developmental disabilities through community mobilization and parents' partnership. The assisted living facility was inaugurated on 21st February 2016 by the then Chief Minister of Gujarat, Anandiben Patel. This place has become famous as 'Ananddham' - an Abode for Persons with Intellectual Disabilities. It is a green belt of 12.5 acres in Aadroda village, Ta.: Bavla, Dist.: Ahmedabad.

## ABOUT ANAND DHAM

Anand Dham is a residential resort for God's chosen ones. The home is built for intellectually challenged individuals who need special care, at an age when they need to be looked after for a longer duration by being under someone's constant supervision. It has an abundance of nature around for the individuals to get acquainted with, while we provide them with adequate physical and stimulating activities, and engage them in a safe, secure premise. Anand Dham's endeavour is to offer the intellectually challenged individuals a quality of life that their aging parents want them to enjoy after they are gone. We offer group accommodation or cubical units and several other residential options that include supervised and independent living. Along with our residential program, we also offer basic training in life skills. Our goal is to provide quality services by offering and training individuals on a one-to-one basis for meaningful, skillful, and competitively paid jobs in the organization. We provide various vocational opportunities so that everyone can be trained according to their needs and can be given the opportunity to choose the type of job they are interested in.

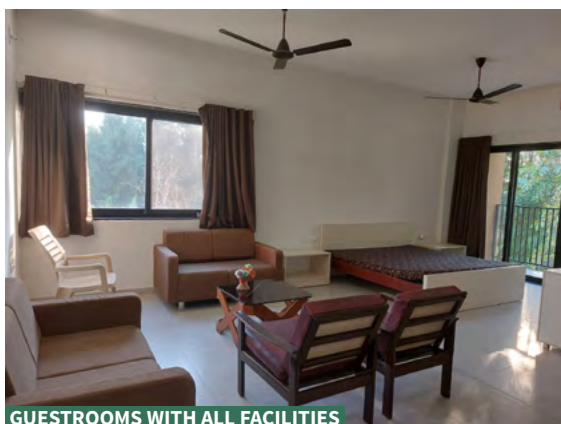

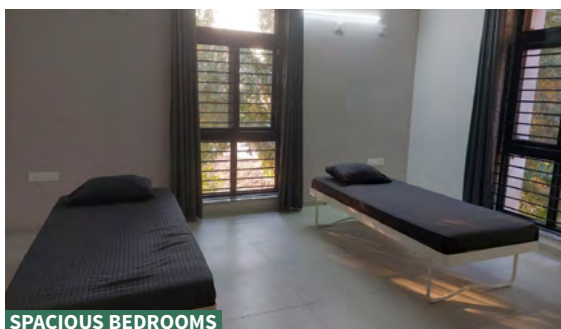

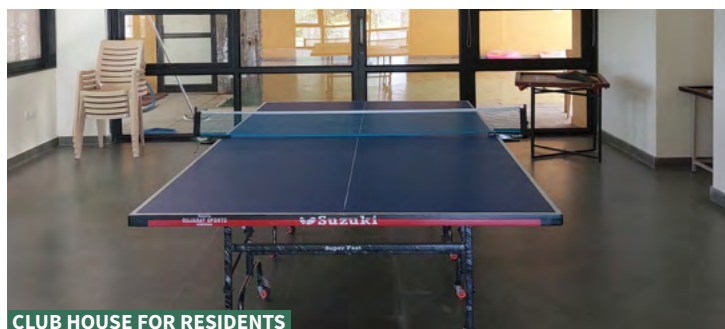

# ACTIVITIES

In the year 2023-24 we welcomed 9 new intellectually challenged members in our campus. Now our strength is 88 (66 males + 22 females). The more admission we get in Ananddham, the more activities we need to organise to keep them engaged and active. To provide them with the best of services on campus, Anand Dham organises following various activities, so that they can feel at home and enjoy each day of their lives.

1. Assigning various day to day responsibility as per their interest and abilities.
2. Training in Domestic Skills and Soft Skills.
3. Exercises, Yoga and Walking.
4. In-Door and Out-Door games.
5. Leisure time activity including watching TV, Watching Movie, Celebration of various festivals, Dance, Music, painting, playing indoor- outdoor Games, Gardening etc.
6. Recreational Activities like celebration of Birthdays, Gardening and Plantation.
7. Vocational training to equip them towards outside campus.

## THERE ARE THREE GROUPS OF RESIDENTS IN ANANDDHAM

### GROUP A

These are the residents who are independent in their daily living activities. Our caregivers train them to assist them in other activities of the campus.

### GROUP B

These are the residents who are able to perform their daily activities independently but with supervision. Caregivers train them to do all these activities without any supervision.

### GROUP C

These are the residents who are not able to perform their daily routine activities. Our caregivers are providing them required services and training to perform their daily activities.

Apart from the daily living activities, Ananddham provides various vocational training to keep them engaged for the day. For that the residents of Anand Dham follow daily schedules of ON-THE-JOB TRAINING PLACEMENT at various vocations on campus. In addition to ADL and vocational training, they also perform housekeeping activities as a part of independent living. Our services are designed to support everyone to live a sustainable independent life and actively engage in their areas of interest.

For the recreation of the residents, all the festivals are celebrated with full of joy. Birthday celebrations of residents are very common in Ananddham which give them the feeling of how important and precious they are for us. All the national and religious festivals are also celebrated with the information about importance of such festivals.

Here are some of the major and important activities took place in Ananddham.

## BIRTHDAY CELEBRATIONS

Birthday is a special day for everyone whether it's their own birthday or others. It's a day of dancing, singing, eating, playing, and enjoying together. Parents are also invited to attend the birthday to make this day special for birthday boys/girls. Once in a month we organise a grand birthday celebration and cut individual cakes. We have also started inviting School Childrens, VIP Guests and Donors in the birthday celebration our residents. This has created a huge success in changing the mentality of the society that these angels are also a part of our society. On the other hand, our "children" are also happy to meet new people on the campus. It gives them a feeling of inclusivity by the society.





## DISABILITY CERTIFICATION CAMP

The central government has made it compulsory to apply for UDID card to take benefits of various government schemes. Many of our residents are above 40 and had old handwritten disability certificates issued by government authorities. It was difficult to take them to the hospital and apply for new disability certificate and UDID card. Ananddham approached Government Mental Hospital, Ahmedabad with this issue and they immediately agreed to come to Ananddham and complete the procedure for the certificate. Dr. Bibin A. Zachariah (Consultant Clinical Psychologist) and Dr. Bhawna Jairam Tahiliani (Consultant Psychologist) visited Ananddham on 9th January 2024 and evaluated our 33 residents who required new certificates and UDID cards. Within two weeks we received the copy of certificates.

## INTERNATIONAL WOMEN'S DAY CELEBRATION

8th March is celebrated as International Women's Day to recognize and celebrate women's achievements. Ananddham also appreciates women for their active involvement in day-to-day operations. To recognize their contribution, we celebrated Women's Day in our campus. Swetaben Shah, our office staff member was given a certificate of appreciation for her valuable contribution in the organisation.



## ART AND CRAFT WORKSHOP

Darpan Academy is one of the best academies run by Dr. Mallika Sarabhai, a renowned activist and Indian classical dancer and actress from Ahmedabad, Gujarat. She has been associated with Ananddham from a long time to improve various skills of our residents. This year also during 11-14 May 2024, Darpan organised art and craft workshop in our campus for our residents. The workshop included various sessions like storytelling, jewellery making, drawing, dancing and stamping.



## CAREGIVERS TRAINING

The biggest pillar of Ananddham is its workforce which needs to be updated regularly for better results. During 8-9 February 2024, we organized a two-day workshop for our caregivers to improve their knowledge and skills. The workshop included behavior issues, daily living activities, and safety. Trainers from Blind People's Association Shri Mihir Jani, Shri Krupaben Velani, and Shri Jignaben Joshi conducted the workshop.



## AMPHITHEATRE

Music and dance are the best therapy for intellectually challenged people. It was a wish of all our trustees and residents to have a permanent place for entertainment. Finally, we inaugurated a huge amphitheatre with the capacity of 300 people where all our residents can dance and sing. The amphitheatre is very helpful to utilise their energy and calm down.



## STORY TELLING BY ANIL GUPTA JI

Everyone likes story and if it is narrated by Anil Gupta, people will enjoy it. Anil ji is a retired bank officer stays in Bavla and has wonderful relation with Ananddham. He decided to spend a quality time with our residents and started narrating Panchtantra story series with them. It worked so well that every Friday our residents wait for him to listen a new story with wonderful life message. Our all the residents learned nice messages through these stories.



## ACTIVITIES

### TRUSTEES AND ADVISORY BOARD MEETING

All the trustees and advisory board members are very much proactive to take Ananddham one step ahead of it is now. Considering the future development and requirement a general meeting was organised on 26th August 2023, Wednesday. Trustees and board members had a fruitful discussion for future projects for Ananddham. Focus was given to create more opportunities for our residents to utilise their skills.



### TRAINING FOR STAFF REGARDING FIRE SAFETY

Ananddham is always conscious about the safety of its residents and staff. Recently we had a safety inspection by a team of specialists and followed the suggestions provided in the safety report. Fire safety training is a must for our staff to prevent any incident due to fire or short circuits. A safety team from Harsha Engineers visited Ananddham on 27th February 2024 and trained all our staff members. Different fires, fire distinguishers and its operations were explained practically.



### SPECIAL KHEL MAHAKUMBH

Since last two years Ananddham has been participating in Special Khel Mahakumbh and doing well. This year also we participated in Athletic games at district level in two categories. The games were organised on 21st and 22nd February 2024 in Ahmedabad.

**Soham Patel, our intellectually challenged resident got 1st prize in 100 metre running in above 40 category and selected for the state level game.**

### ANNUAL DANCE COMPETITION BY SWMR

Society for the Welfare of Mentally Retarded organise dance competition to provide platform to intellectually challenged people every year. This year also on 2nd March 2024, they organised a dance competition in Tagor Hall, Ahmedabad. Residents of Ananddham also participated in the competition and performed a Garba.

## DIWALI SNEH MILAN

Diwali is a festival of light, and our staff members are spreading light in the lives of each resident. Management knows that each staff is important member of Ananddham and therefore, trustees decided to celebrate Diwali with staff members organising a sneh milan on 25th November 2023. Trustees thanked all the staff members for being a part of Ananddham and changing lives of residents. Trustees announced Diwali gift to all the staff members as a token of gratitude.



## BIRTHDAY CELEBRATIONS BY GUESTS

Ananddham welcome its well-wishers to organise their family members birthdays and anniversary in Ananddham and make them a part of their happiness. During the year, many events were organised by outsiders and our residents enjoyed a lot. The events gave wonderful message of inclusion where intellectually challenged people are involved in the celebration by society. One of the best events was birthday of Kaushik Shah's grandson Hreyansh which was celebrated on 6th December 2023 in Ananddham. It was a whole day event with dance, music and games which all of us enjoyed a lot.



## VISIT BY SUPER BIKE RIDERS

On 16th April 2024, Castrol Oil organised a marketing event in Ananddham. More than 50 bike riders with their superbikes visited Ananddham in this event. There were some superbikes which our residents never seen before. The bike riders were very friendly with our residents, and they took our residents for a small ride in the campus.





## BEING AUTONOMOUS... FURTHER PROGRESS

Ananddham started a concept of being autonomous in year 2022-23. It was an attempt to provide various opportunities to our residents to use their skills and do what they like. The concept worked properly, and they got options to either work in campus or go outside in Aastha and Innovative Foods.

### Following activities were done under this project during the 2022-23.

- We started organic farming in a small land near girls building on a trial basis.
- Started experiment of sending our residents in Aastha if they are comfortable of new work schedule and place
- Started making khakhra with one team of boys and girls.
- Started giving fake money as a motivation which they can use to buy products.

In the year 2023-24, we went further ahead with the confidence of our residents. We developed a greenhouse on 1 acre land for organic farming equipped with drip irrigation system. We have planted various vegetables like Cucumber, Tinda, Tomato, Bottle gourd, Bitter gourd etc which we will grow without any pesticides. These vegetables will be used in our kitchen so that the residents can have healthy food.

For the khakhra making process, we prepared different teams of boys and girls who work in a shift. We provide them training to enhance their skills for various station so that the process can not get affected if any resident is not present in the workshop. This has improved our speed and now we make more than 60 kg khakhra every day.



Today, 40% of our residents are going outside for different activities. Aastha has become another workplace and daily 24 residents are going to work. The collaboration with Innovative Foods LLP to provide training to our 7 residents has been working effectively. They are learning packing, weighing and sealing in factory premise which build their confidence to work in normal environment.

Paper sorting activity for mild and moderate residents has also made them productive as much as they can. We understand their limited ability and provide work accordingly. However, it is a mission of Ananddham to give work to each resident so that they can live respectfully.

They get fake money as compensation of their work which they use to buy different items available in our shop. Through this concept we want to train them in financial transaction as well self-reliance.

There is a long way to make them autonomous, but we are happy to bring change in their lives within two years.
