It is with great pleasure that I present the Annual Report for the year 2024–25.

Our lush 12.5-acre campus continues to flourish, with expanding plantations, manicured lawns, and the recent addition of a greenhouse for cultivating organic vegetables. The serene, green environment is steadily enhancing the quality of life for our residents.

Over the past three years, our management team has worked tirelessly to help residents move from dependence to independence, and now toward a life of greater autonomy. We are beginning to see meaningful outcomes—residents are increasingly engaged in productive work and cultural activities, bringing renewed joy and purpose to their lives.

Inspired by this progress, we are launching a new Training Centre dedicated to preparing young individuals (aged 15 to 25) for fully independent living. The program will include life skills and vocational training tailored to each person's abilities, with training durations ranging from three months to one year. The goal is to equip them to find suitable jobs near their homes and lead dignified, self-reliant lives.

We remain committed to providing the highest standards of care. One ongoing challenge has been staff turnover, largely due to lack of accommodation. To address this, we have started constructing a multi-storey residential facility for staff within the campus. This ₹6.5 crore project is expected to be completed by the end of 2025.

We have also begun building two new blocks for female residents and a roadside shop-cum-café. This café will serve a dual purpose: providing training in retail and hospitality to our residents and generating income to support our initiatives. These new facilities are expected to be ready by July 2025.

Last year, we appealed for contributions to the Ashram Nivasi Fund, which helps support residents whose families are unable to afford full fees. We are humbled by the generous response, especially the ₹1 crore donation received from the Late Sarojben Dalal Trust, through their executor, Advocate Mihir Thakore. We extend our heartfelt gratitude for this extraordinary support.

To all our donors—thank you. Your unwavering faith and generosity inspire us to do more and do better, every day. We warmly invite you to visit this peaceful haven, meet our dedicated team, and witness the transformation taking place here.

Our sincere thanks to all donors, trustees, members of the advisory and medical committees, and especially to our devoted staff. We are also grateful to the parents and guardians for their trust, encouragement, and continued support.

Historical Perspective


SOCIETY FOR THE WELFARE OF THE MENTALLY RETARDED was established in 1968 and it was the first group of parents that enrolled their children with us.

The aim of the association was to comfort the parents and answer their question 'Who will take care of our children after us?'.

To fulfil parents' concerns AASTHA CHARITABLE TRUST FOR THE MENTALLY CHALLENGED was formed with the mission to provide a dignified life and qualitative care through a residential 'HOME' for the persons with intellectual and developmental disabilities through community mobilization and parents' partnership. The assisted living facility was inaugurated on 21st February 2016 by the then Chief Minister of Gujarat, Anandiben Patel. This place has become famous as 'Anand Dham'- an Abode for Persons with Intellectual Disabilities. It is a green belt of 12.5 acres in Aadroda village, Ta.: Bavla, Dist.: Ahmedabad.

ABOUT ANAND DHAM

Anand Dham is a residential resort for God's chosen ones. The home is built for intellectually challenged individuals who need special care, at an age when they need to be looked after for a longer duration by being under someone's constant supervision. It has an abundance of nature around for the individuals to get acquainted with, while we provide them with adequate physical and stimulating activities, and engage them in a safe, secure premise. Anand Dham's endeavour is to offer the intellectually challenged individuals a quality of life that their aging parents want them to enjoy after they are gone. We offer group accommodation or cubical units and several other residential options that include supervised and independent living. Along with our residential program, we also offer basic training in life skills. Our goal is to provide quality services by offering and training individuals on a one-to-one basis for meaningful, skillful, and competitively paid jobs in the organization. We provide various vocational opportunities so that everyone can be trained according to their needs and can be given the opportunity to choose the type of job they are interested in.
















ACTIVITY REPORT

Anand Dham is a Home away from Home. It is an assisted living, long stay facility located in a green belt near Ahmedabad in a 12.5 Acres land. Persons with Intellectual and Developmental Disabilities (IDD) exercise their rights; make their own choices and self-determine their course of life and daily routines. Intellectually challenged individuals who need special care, especially at an age when they need to be looked after in a long stay home with caring supervision, in spacious green environment, package of physical and stimulating activities, and engagement in a safe, secure premises. The endeavour of Anand Dham is to offer these challenged persons a quality of life that their aging parents had wanted them to enjoy after they are gone.

In the year 2024-25 we welcomed 12 new intellectually challenged members in our campus. Now our strength is 100 (88 males + 22 females). The more admission we get in Anand Dham, the more activities we need to organise to keep them engaged and active. To provide them with the best of services on campus, Anand Dham organises following various activities, so that they can feel at home and enjoy each day of their lives.

- Assigning various day to day responsibility as per their interest and abilities.
- 2. Training in Domestic Skills and Soft Skills.
- 3. Exercises, Yoga and Walking.
- 4. In-Door and Out-Door games.
- Leisure time activity including watching TV, Watching Movie, Celebration of various festivals, Dance, Music, painting, playing indoor- outdoor Games, Gardening etc.
- 6. Recreational Activities like celebration of Birthdays, Gardening and Plantation.
- 7. Vocational training to equip them towards outside campus.

THERE ARE THREE GROUPS OF RESIDENTS IN ANAND DHAM

GROUP A

These are the residents who are not able to perform their daily routine activities. Our caregivers provide them training to make them independent in these activities.

GROUP B

These are the residents who are able to perform their daily activities independently but with supervision. Caregivers train them to do all these activities without any supervision.

GROUP C

These are the residents who are independent in their daily living activities. Our caregivers train them to assist them in other activities of the campus.

Apart from the daily living activities, Anand Dham provides various vocational training to keep them engaged for the day. For that the residents of Anand Dham follow daily schedules of ON-THE-JOB TRAINING PLACEMENT at various departments on campus. In addition to ADL and vocational training, they also perform housekeeping activities as a part of independent living. Our services are designed to support everyone to live a sustainable independent life and actively engage in their areas of interest.

For the recreation of the residents, all the festivals are celebrated with full of joy. Birthday celebrations of residents are very common in Anand Dham which give them the feeling of how important and precious they are for us. All the national and religious festivals are also celebrated with the information of the important of such festivals.

During the year 2024-25, Anand Dham carried out following activities for its residents.

BIRTHDAY CELEBRATIONS

Birthday is a special day for everyone whether it's their own birthday or others. It's a day of dancing, singing, eating, playing, and enjoying together. Parents are also invited to attend the birthday to make this day special for birthday boys/girls. Once in a month we organise a grand birthday celebration and cut individual cakes. We have also started inviting guests to celebrate birthdays on campus and share their happiness with our "children". This has created a huge success in changing the mentality of the society that these angels are also a part of our society. On the other hand, our "children" are also happy to meet new people on the campus. It gives them a feeling of inclusivity by the society.



SHRIHAN'S BIRTHDAY

Mr. Hirenbhai Chokshi and family celebrated Shrihan's birthday on 22nd December 2024. Whole family and relatives were invited to Anand Dham to be a part of the celebration. It was a memorable day for everyone including residents and staff members of Anand Dham.

Trustees thanked the staff members for their commitment towards Anand Dham and requested to continue it. They declared to start a credit society for staff members where they can save certain amount of their salary and spend it in any emergency.



WEEKLY DRAWING WORKSHOP

We have started a weekly drawing workshop for our residents who are interested in drawing and painting. Mr. Bharatbhai Pipavat, a drawing teacher visits Anand Dham on every Tuesday and conduct drawing classes for both male and female residents separately. He also teaches various designs for our ceramic pots which our residents like and try on pots.

CAREGIVERS AND RESIDENTS TRAINING

The biggest pillar of Anand Dham is its workforce which need to be updated regularly for better result. To train our caregivers and selected residents, we have joined hands with Qi 2 Happiness Foundation, Ahmedabad. A team of the organisation visit Anand Dham every alternate Tuesday and spend four hours with our residents and staff members. They take different topics and themes for training and use different methods with our residents and staff. The themes include behaviour issues, daily living activities and safety.





TRUSTEES AND ADVISORY BOARD MEETING

All the trustees and advisory board members are very much proactive to take Anand Dham one step ahead of it is now. Considering the future development and requirement a general meeting was organised on 19th October 2024, Saturday. Trustees and board members had a fruitful discussion for future projects for Anand Dham. Focus was given to create more opportunities for our residents to utilise their skills.
