

HISTORY AND CONCEPT

Historical Perspective

SOCIETY FOR THE WELFARE OF THE MENTALLY RETARDED was established in 1968 and it was the first group of parents that enrolled their children with us.

The aim of the association was to comfort the parents and answer their question **‘Who will take care of our children after us?’**.

To fulfil parents’ concerns AASTHA CHARITABLE TRUST FOR THE MENTALLY CHALLENGED was formed with the mission to provide a dignified life and qualitative care through a residential ‘HOME’ for the persons with intellectual and developmental disabilities through community mobilisation and parents’ partnership. The assisted living facility was inaugurated on 21st February 2016 by the then Chief Minister of Gujarat, Anandiben Patel. This place has become famous as ‘Anand Dham’- an Abode for Persons with Intellectual Disabilities. It is a green belt of 12.5 acres in Aadroda village, Ta.: Bavla, Dist.: Ahmedabad.

ABOUT ANAND DHAM

Anand Dham is a residential resort for God’s chosen ones. The home is built for intellectually challenged individuals who need special care, at an age when they need to be looked after for a longer duration by being under someone’s constant supervision. The campus has an abundance of nature around for the individuals to get acquainted with, where we provide them with adequate physical and stimulating activities, and engage them in a safe, secure environment. Anand Dham’s endeavour is to offer the intellectually challenged individuals a quality of life that their aging parents want them to enjoy after they are gone. We offer group accommodation or cubical units and several other residential options that include supervised and independent living. Along with our residential program, we also offer basic training in life skills. Our goal is to provide quality services by offering and training individuals on a one-to-one basis for meaningful, skillful, and competitively paid jobs in the organization. We provide various vocational opportunities so that everyone can be trained according to their needs and can be given the opportunity to choose the type of job they are interested in.







ACTIVITIES

In the year 2022-23 we welcomed 10 new intellectually challenged members in our campus. Now our strength is 79 (64 males + 15 females). The more admission we get in Anand Dham, the more activities we need to organise to keep them engaged and active. To provide them with the best of services on campus, Anand Dham organises following various activities, so that they can feel at home and enjoy each day of their lives.

1. Assigning various day to day responsibility as per their interest and abilities.
2. Training in Domestic Skills and Soft Skills.
3. Exercises, Yoga and Walking.
4. Leisure time activity including watching TV, Watching Movie, Celebration of various festivals, Dance, Music, Painting, Playing indoor-outdoor Games, Gardening etc.
5. Vocational training to equip them towards working off the campus.

The residents of Anand Dham follow daily schedules of on-the-job training placement at various departments on campus. In addition to ADL and vocational training, they also perform housekeeping activities as a part of independent living. Our services are designed to support everyone to live a sustainable independent life and actively engage in their areas of interest. All the festivals are celebrated at Anand Dham including birthday celebrations of all the residents.



NEW RESIDENTIAL BUILDING

On 15th February 2023, we inaugurated our new residential building for our intellectually challenged residents.

The new building will accommodate 31 residents and 1 building in-charge / caregiver. It has all the facilities like other residential buildings (attached bathroom, hot / cold water / individual cupboard / RO and water cooler on each floor / CCTV in each room, common hall with chairs and LED TV). Pooja was offered by our girls and boys. Ribbon was cut by regular donor Shri Rupa Jhaveri who donated computers for our residents last year. Our all residents were very much excited to relocate to the new building.



BIRTHDAY CELEBRATION

Birthday is a special day for everyone whether it's their own birthday or others. It's a day of dancing, singing, eating, playing, and enjoying together. Parents are also invited to attend the birthday to make this day special for birthday boys/girls. Once in a month we organise a grand birthday celebration and cut individual cakes. We have also started inviting guests to celebrate birthdays on campus and share their happiness with our "children". This has created a huge success in changing the mentality of the society that these angels are also a part of our society. On the other hand, our "children" are also happy to meet new people on the campus. It gives them a feeling of inclusivity by the society.



APARAJITA'S BIRTHDAY

We always want society to include our intellectually challenged residents in their happiness. Therefore, we request people to celebrate their birthday and other occasions in our campus so that our residents can have opportunity to meet new people and enjoy the day. As a part of this, Shri Nirja Sharma, who is our regular donor and sponsors half of the fees of one of our residents celebrated her daughter's birthday with us on 15th of December 2022. Nirja ji has visited us number of times, but she wanted to teach good lessons to the next generation so that she can get motivated to work for needy people. It was a wonderful celebration and Aparajita; daughter of Nirja Sharmaji was very happy to share her happiness with our residents.



DENTAL CAMP

Oral care is one of the most important areas where intellectually challenged people need proper medical intervention. Due to their limited ability, they cannot brush their teeth properly which leads to dental problems after a certain age. At Aastha Charitable Trust Anand Dham our inmates are 30+ and we are always concerned about their health and hygiene.

On 26th April 2022, we organized a mega dental camp on our campus with the support of Ahmedabad Dental College and Hospital. A team of more than 25 senior doctors, residents, and interns travelled to our campus with their mobile dental van and spent a day treating our inmates. To remove their fear and build a rapport, they played several games with our inmates and then started treatment. This method really helped us to get proper treatment. We are very much thankful to all the team members of Ahmedabad Dental College and Hospital.

Our Managing trustee Shri Raju sir remained present during the whole camp and explained the motto of Anand Dham to the team of dental college.



AADHAAR CARD CAMP

AADHAAR card is one of the most important documents to get government

benefits for divyang people. Some of our inmates did not have AADHAAR cards and we were trying to communicate with district authorities. Finally, On 8th June 2022, with the support of the District Collector of Ahmedabad and the Social Defence Office, Ahmedabad, an AADHAAR enrolment camp was organized in Anand Dham. Officers from both departments came to our campus and completed the registration. After few days, we also received copy of AADHAAR card in our campus address. We are very much thankful to district authorities to organise camp in our campus as it is difficult to take our intellectually challenged people at public places sometimes.

TRUE FRIENDSHIP...!!!

9th April 2022 was a great day for Vikram Khandekar. He was going to meet his childhood school friends after years. A group of Balmohan Vidyamandir, Mumbai met after years and remembered Vikram. They found him in Anand Dham after a long struggle of search. Two years ago, they all invited Vikram in Mumbai and gave him surprise. Vikram also invited all of them to visit Anand Dham. On 9th April, all friends visited Anand Dham and met Vikram, his friends, and our trustees Shri Parag sir and Raju sir. They were very happy to see Anand Dham and its facilities. Vikram introduced our staff members, trustees, and all his friends. Vikram's friends were very much friendly and excited to meet other inmates. DEPENDENT TO INDEPENDENT... INDEPENDENT TO AUTONOMOUS...

The main purpose of starting Anand Dham was to provide a better life to intellectually challenged individuals when their parents/guardians are incapable of taking care of them or pass away. Looking at this depressing eventuality, the trustees of Anand Dham went about creating world-class facility near Adroda village in Gujarat, providing the best possible facilities in a lush green campus embedded with residential homes, physiotherapy centre, dental care, workshops, swimming pool, an amphitheatre and a guest house making it a welcoming self sustained unit.

Intellectually challenged adults who are the inmates in the campus, have progressively learnt to live and handle their lives more independently and lead their daily lives without any assistance. But this was just a beginning of Anand Dham. As the number of residents increased some challenged adults were found competent in acquiring different skills which could enhance their quality of life and upgrade their confidence and self- perception. ADL skills like brushing, bathing, dressing, drinking, eating, combing, and shaving to complete daily living activities independently became a satisfying achievement for the caregivers. In turn, the caregivers got some time to learn new skills and develop their capacity to work more efficiently. Anand Dham is now thinking of going a step further and make the inmates autonomous by facilitating their ability to make a choice.

For instance, today Anand Dham's proud residents have many choices in their day-to-day life. Anand Dham workshop is a special place where the residents work in various

occupations for a salary on a daily basis. They have the right to spend their earnings to buy daily living items like soaps, shampoo, hair oil, toothpaste, toothbrush etc. If not, they have the choice to deposit their money in Anand Dham Bank and can withdraw when they need. The residents live their life in the way they want and this is the first step in promoting an autonomous existence.

Their right to choose also extends itself select the work from various options from gardening to manufacturing as per their ability and interest. This model has created confidence in their life. They discuss about their choices, likes, dislikes, value and especially importance of money. They now appreciate 'value' and have a greater sense of identity and confidence.



SECOND PHASE OF CONSTRUCTION

The journey of the second phase construction started on 30th August 2021 in the presence of Shri Bhupendrasinh Chudasama (Ex. Education and Law Minister, Govt. of Gujarat), Padmashree Dr. Sudhir Shah (Reputed Neurologist), Shri Mihir J. Thakor (Sr. Advocate) and Shri Pravinbhai A. Shah (President - Ambawadi Jain Sangh) and Shri Narendrabhai Mehta (Structural Consultant). The second phase of construction included three residential units and a vocational and rehabilitation workshop.




